The purpose of the Proclamation is to increase awareness and understanding of mental illnesses, reduce stigma and discrimination and promote appropriate and accessible services for all people with mental illnesses. The Board considered an Application for General Assistance from Chris Brewer requesting funds for a County burial for Brett Brewer. County Attorney Schaub has reviewed the Application and found that all requirements had been met and recommended approval of the Application. A motion was made by Miller, seconded by Sanders to approve the Application as reviewed. Roll Call: Aye: Miller, Sanders. Nay: None. Absent: Johnson.

Next, an Application for General Assistance from Patricia Lloyd requesting funds for a County burial for Angela Toman. County Attorney Schaub has reviewed the Application and found that all requirements had been met and recommended approval of the Application. A motion was made by Miller, seconded by Sanders to approve the Application as reviewed. Roll Call: Aye: Sanders, Miller. Nay: None. Absent: Johnson.

County Attorney Schaub presented an Agreement with the Lancaster County Youth Services for juvenile detention services. This Agreement is for holding pre-adjudicated youth, youth held on adult charges or out-of-state runaways in the facility. The new rate is \$334.00 per day. Portions of the day will be prorated. Cheyenne County is responsible for the cost of all medical care including pharmaceuticals. Cheyenne County is also responsible for the cost of emergency transportation and or any instance where one-to-one supervision is required to ensure the safety of the youth. County Attorney Schaub stated that we currently have an Agreement with the Lancaster County Youth Services. A motion was made by Sanders, seconded by Miller to approve the renewal Agreement. Roll Call: Aye: Miller, Sanders. Nay: None. Absent: Johnson.

Scott Bauer addressed the Board regarding identity theft.

Melissa Norgard appeared to request use of the County stage for the Downtown Sounds Concerts on June 21st, July 19th and August 16th. It was the decision of the Board that County property will remain on County property.

Brooke DeNovellis, Chairman of the Visitors Committee, addressed the Board regarding an improvement grant for the Dalton Senior Citizens. At the March 18th meeting, this grant was approved in the amount of \$2,000.00. The amount approved by the Visitors Committee and the amount that should have been presented to the Commissioners on March 18th was for \$2,500.00. A motion was made by Miller, seconded by Sanders to correct the amount of the improvement grant to the Dalton Senior Citizens from \$2,000.00 to \$2,500.00. Roll Call: Aye: Sanders, Miller. Nay: None. Absent: Johnson.

Cheyenne County Highway Superintendent Doug Hart addressed the Board regarding quotes for Culvert Project C-17-183. There was one quote submitted from Ace/Eaton Metals from Kearney, Nebraska. The quote was for 2 – 72" x 40' 10 GA 5x1 with headwall with 15' sheetpile 7 GA, 4 walers, 12 sheet piling, 6 – 50' tiebacks and cable clamps in the amount of \$46,807.20. After a review of the quote, a motion was made by Miller, seconded by Sanders to approve the quote from Ace/Eaton Metals in the amount of \$46,807.20. Roll Call: Aye: Miller, Sanders. Nay: None. Absent: Johnson.

The discussion regarding the purchase of a paint striper was tabled.

Next, Highway Superintendent Hart updated the Board on road activities.

There were no comments from the public.

A motion was made by Miller, seconded by Sanders to remove all signs pertaining to firearms from all Cheyenne County buildings immediately. Roll Call: Aye: Sanders, Miller. Nay: None. Absent: Johnson. Further Sheriff Adam Frerichs and Deputy Sheriff Ron Kissler were directed to develop language for the new signage.

There being no further business to come before the Board, Vice-Chairman Sanders declared the meeting adjourned at 10:10 A.M.
