

Cheyenne County Fair Board Meeting

April 8, 2024

The Cheyenne County Fair board held a special meeting on Monday, April 8, 2024 in the Cheyenne County Fairboard office at 10955 Hwy 30, Sidney, Nebraska. A notice of this meeting was published on 4/4/24, at the Sidney Sun Telegraph, the Cheyenne County website and Cheyenne County bulletin board. Copies of the agenda were transmitted to each Fairboard Member. Minutes are kept current and available to the public at the Cheyenne County Clerk's Office.

Old Business:
