# CHEYENNE COUNTY BOARD OF COMMISSIONERS AND BOARD OF EQUALIZATION MEETING

## **NOVEMBER 21, 2022**

The Cheyenne County Board of Commissioners and Board of Equalization held an open and public meeting on Monday, November 21, 2022 in the Cheyenne County Commissioners Meeting Room, Cheyenne County Court House, 1000 10<sup>th</sup> Avenue, Sidney, Nebraska. A notice of this meeting was published in the Sidney Sun-Telegraph, aired on KSID Radio, posted on the bulletin board in the County Court House and on the Cheyenne County website. Copies of the agenda were posted on the Court House bulletin board and on the Cheyenne County website, transmitted to each Commissioner and kept current and available to the public at the County Clerk's Office.

Chairman Darrell J. Johnson called the meeting to order at 8:00 A.M., with the following present:

A motion was made by Sanders, seconded by Miller to approve and pay all claims as stated above. Delinquent taxes were deducted where owing. Roll Call: Aye: Miller, Sanders, Johnson. Nay: None.

The Board reviewed Monthly Fee Reports for the month of October for the Clerk, Treasurer, Clerk of the District Court and Highway Superintendent and for the months of September and October for the Sheriff. A motion was made by Sanders, seconded by Miller to approve the Monthly Fee Reports as presented. Roll Call: Aye: Sanders, Johnson, Miller. Nay: None.

The Board then reviewed Resolution 2022-24 authorizing the County Treasurer to transfer \$902,085 from County General 100 Fund to County Road/Bridge 300 Fund to provide adequate funding for the Road Department. The Road/Bridge Department does not receive tax dollars. In order to provide adequate funding, it is necessary to transfer funds from the County General 100 Fund. In the 2022-2023 County budget, the amount of \$902,085 was determined to be the amount needed to provide funding for the Road Department. Of the \$902,085 to be transferred, one-half of the funds will be transferred before December 31, 2022 and the other one-half will be transferred by April 30, 2023. After a discussion, a motion was made by Sanders, seconded by Miller to adopt Resolution 2022-24 authorizing the County Treasurer to transfer the sum of \$902,085 with \$451,043 being transferred before December 31, 2022 and \$451,043 being transferred by April 30, 2023 to provide adequate funding for the Road Department. Roll Call: Aye: Johnson, Miller, Sanders. Nay: None. A complete copy of the Resolution as adopted is on file at the Office of the County Clerk.

The 2021-2022 Audit report has been completed and is on file in the office of the Cheyenne County Clerk. The Board examined the Audit prepared by Donald D. Wilson, CPA. After a phone conference with Mr. Wilson and a discussion, a motion was made by Miller, seconded by Sanders to approve the 2021-2022 Cheyenne County Audit as reviewed. Roll Call: Aye: Miller, Sanders, Johnson. Nay: None.

At 8:25 A.M., a motion was made by Sanders, seconded by Miller to recess the Board of Commissioners and reconvene as the Board of Equalization. Roll Call: Aye: Sanders, Johnson, Miller. Nay: None.

Cheyenne County Assessor Melody Keller presented a Tax List Correction for the homestead exemption for Allan L. Bauer for the year 2019. Pursuant to a letter from the Property Assessment Division Tax Commissioner, the Nebraska Department of Revenue has become aware of additional income that had not been disclosed on the 2019 homestead exemption application previously filed. The report went on to state, that based on the additional income, the homestead exemption has been adjusted from 100% to 60%. A motion was made by Miller, seconded by Sanders to approve the Tax List Correction as presented. Roll Call: Aye: Johnson, Miller, Sanders. Nay: None.

Next, Assessor Keller submitted a Tax List Correction for Cody A. Barber and Cassie Dawn Barber for the Tax Year 2022. Keller reported that, due to a system error, a penalty was added to this property. A motion was made by Miller, seconded by Sanders to approve the Tax List Correction removing the penalty that was inadvertently added to the property owned by Cody A. Bauer and Cassie Dawn Bauer. Roll Call: Aye: Miller, Sanders, Johnson. Nay: None.

At 8:35 A.M., a motion was made by Miller, seconded by Sanders to adjourn the Board of Equalization and reconvene as the Board of Commissioners. Roll Call: Aye: Sanders, Johnson, Miller. Nay: None.

County Attorney Paul Schaub discussed with the Board a 5-Year Master Agreement with the Nebraska Department of Transportation for County Survey Services. The purpose of the Agreement is to establish a State-County standard process for the County to fulfill its statutory duty to perpetuate survey corners when necessary for highway projects. Prior to the start of a highway project for the construction, reconstruction, resurfacing or maintenance of a State highway, the County will confirm the location of certain survey corners and confirm the location of existing reference points or, if necessary, set reference points for the survey corners. After construction, the County will re-establish any survey corner monuments disturbed by the highway project. The State agrees to pay a lump sum of \$300 for all new reference monuments and ties set for a survey corner and for any survey corners actually re-established after completion of the highway project. A motion was made by Sanders, seconded by Miller to adopt Resolution 2022-25 approving the 5-Year Master Agreement as above stated. Roll Call: Aye: Johnson, Miller, Sanders. Nay: None. A complete copy of the Resolution as adopted is on file at the Office of the County Clerk.

Cheyenne County Highway Superintendent Doug Hart updated the Board on road activities.

At 8:45 A.M., Chairman Johnson declared the public hearing open to review and consider approval of the One- and Six-Year Highway Improvement Plan.

Superintendent Hart reviewed the One- and Six-Year Highway Improvement Plan. There was a discussion. A motion was made by Miller, seconded by Sanders to adopt Resolution 2022-26 approving and accepting the One- and Six-Year Road Improvement plan as reviewed. Roll Call: Aye: Miller, Sanders, Johnson. Nay: None. A complete copy of the Resolution as adopted is on file at the Office of the County Clerk.

9:01 A.M., Chairman Johnson declared the public hearing closed.

At 9:01 A.M., the Board of Commissioners meeting was recessed to attend County Government Day in the Cheyenne County District Courtroom.

Under comments from the public, Marguerite Pool and Eric Pool spoke to the Board.

There being no further business to come before the Board, Chairman Johnson declared the meeting adjourned at 9:33 A.M.
