## CHEYENNE COUNTY PLANNING COMMISSION

A meeting of the Cheyenne County Planning Commission was convened at 3:00 P.M., on February 26, 2024, in the Commissioner's Meeting Room of the Cheyenne County Courthouse.

Notice of the meeting was given in advance thereof by publication in <a href="The Sidney Sun-Telegraph">Telegraph</a> and posted on the bulletin boards at the Cheyenne County Court House, 1000 10<sup>th</sup> Avenue, Sidney, Nebraska, Cheyenne County Annex Building, 920 Jackson Street, Sidney, Nebraska, and at the Cheyenne County Highway Superintendent Building, 2383 Illinois Street, Sidney, Nebraska. Copies of the agenda were posted on the bulletin boards at the Cheyenne County Court House, the Cheyenne County Annex Building, and at the Cheyenne County Highway Superintendent Building on February 15, 2024, for the public hearing to be held on February 26, 2024. A copy of Proof of Publication is attached to these minutes. Advance notice of the meeting was also given to the Chairman and all members of the Commission.
