The Cheyenne County Board of Commissioners and Board of Equalization held an open and public meeting on Monday, November 3, 2025, in the Commissioners Meeting Room, Cheyenne County Court House, 1000 10th Avenue, Sidney, Nebraska. A notice of this meeting was published in the Sidney Sun-Telegraph on October 30, 2025, aired on News Channel Nebraska Radio, posted on the bulletin board in the County Court House and on the Cheyenne County website. Next, the Contact Person for the Nebraska Intergovernmental Risk Management Association (NIRMA), the County's insurance carrier, was discussed. The Contact Person acts as the liaison between the County and NIRMA. A motion was made by Miller, seconded by Sanders to appoint Jordan Hajek as the new Contact Person effective January 2, 2026. A motion was made by Sanders, seconded by Miller to table the discussion regarding the health insurance buyback program. Roll Call: Aye: Miller, Sanders, Johnson. Nay: None.

Cheyenne County Attorney Amber Horn discussed with the Board the General Assistance application from Amy Smith for a County burial for Linda Andrews. County Attorney Horn stated that the assets of the estate exceed the cost allowed for a County burial and recommended the claim be denied. A motion was made by Sanders, seconded by Miller to deny the claim for general assistance for a County burial for Linda Andrews. Roll Call: Aye: Sanders, Johnson, Miller. Nay: None.

Joe McCarn, Cheyenne County Chamber Director, spoke with the Board considering a Resolution declaring November 24, 2025 through December 13, 2025 Shop Cheyenne County NE Days as a special holiday shopping event. Throughout Shop Cheyenne County NE Days, all residents and visitors are encouraged to shop locally, explore our unique stores and enjoy the holiday spirit that makes Cheyenne County such a special place to live, work and visit. A motion was made by Miller, seconded by Sanders to adopt Resolution 2025-22 declaring November 24, 2025 through December 13, 2025 Shop Cheyenne County NE Days. Hal Enevoldsen appeared before the Board to discuss the Visitors Committee. Mr. Enevoldsen resigned from the Visitors Committee effective June 2, 2025.

Sarah Sinnett spoke to the Board regarding the potential creation of an Economic Development Corporation. The Corporation would be dedicated to strengthening economic vitality by expanding access to quality jobs, supporting local businesses and entrepreneurs and driving innovative strategies that enhance our region's appeal. The corporation would absorb the Economic Development responsibilities typically performed by the City of Sidney. The Corporation would serve as the leading organization for economic development and entrepreneurial support in Cheyenne County. It would operate as an independent 501(c)(3) nonprofit, overseen by its own privately managed Board of Directors.

Veterans Service Officer Fred Wiedeburg addressed the Board regarding a Memorandum of Understanding (MOU) between Cheyenne County and the Nebraska Department of Veterans Affairs (NDVA). The term of the MOU is from January 1, 2026 through December 31, 2028. The MOU allows VSO Wiedeburg to join on NDVA's license to view and add certain information to the web based database "VetraSpec" in order to assist Veterans and/or their eligible dependents to access all benefits which they are entitled by law. A motion was made by Miller, seconded by Sanders to approve the MOU as reviewed. Roll Call: Aye: Miller, Sanders, Johnson. Nay: None.

VSO Wiedeburg then updated the Board on current activities.

Cheyenne County Highway Superintendent Anthony Krajewski presented new Contractual Rates, new permit applications for Road Surface Grading for Private Access Road, for Snow Plowing Private Driveway and Utilities Permit for the Board's review. A motion was made by

Miller, seconded by Sanders to approve the new permit forms and Contractual Rates. Roll Call: Sanders, Johnson, Miller. Nay: None.

The Board reviewed the Year-End Certification of County Highway Superintendent 2025 for Determining Incentive Payment in Calendar Year 2025. The Certification was from January 1, 2025 to July 21, 2025 for former Highway Superintendent Skyler Saucedo and from July 21, 2025 to December 31, 2025 for Highway Superintendent Anthony Krajewski. Also, the Board reviewed Resolution 2025-23 authorizing the County Board Chairman to sign the Year-End Certification of County Highway Superintendent. A motion was made by Miller, seconded by Sanders to adopt Resolution 2025-23 as presented. Roll Call: Aye: Johnson, Miller, Sanders. Nay: None. A complete copy of the Resolution as adopted is on file at the Office of the County Clerk.

Superintendent Krajewski then updated the Board on road activities.

There were no comments from the public.

At 9:30 A.M., a motion was made by Miller, seconded by Sanders to enter into executive session to discuss pending litigation. Roll Call: Aye: Miller, Sanders, Johnson. Nay: None.
